

Privacy notice for Suppliers of the Veolia Group in Poland (stage: contract)

In connection with the applicability of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data ("GDPR"), we kindly inform you that:

Your personal data or personal data of your representatives, employees, collaborators, proxies, and persons indicated in the Agreement as representing the Party, contact persons, or those responsible for the implementation of individual tasks resulting from the Agreement will be processed in accordance with Art. 6 GDPR paragraph 1 points b), c), and f) (in relation to the points mentioned below) for the purpose of:

- concluding and implementing the contract or purchase order and will be stored for a period of 6 years from the moment when operations, purchase transactions, and procurement procedures have been finally completed, and obligations have been paid, settled, or expired, as well as from the termination of all guarantees and warranties under the contract or order,
- establishing, pursuing, or defending legal claims arising from or related to the Agreement will be stored for a period of 6 years from the completion of its implementation,
- creating statistics, summaries, and analyses for own needs, and then personal data will be stored for a period of 3 years from the last action on personal data.

Providing your personal data is voluntary, but failure to do so will prevent the implementation of the contract or order.

In the case of supplier representatives, their data was obtained directly from the suppliers they represent or from publicly available sources.

We transfer your personal data to entities with which we cooperate for the purposes of using your products and services or for the purposes of using products and services of suppliers you represent, e.g., entities providing postal, courier, accounting, legal, IT services, and companies from the Veolia Group.

Your personal data may be transferred to third countries (outside the European Economic Area), in particular in connection with Veolia's use of global IT solutions. Data may be transferred to third countries for which the European Commission has issued a decision stating that an adequate level of protection is ensured. In the case of third countries for which such a decision has not been issued, the transfer of data may be made each time with the preservation of one of the solutions aimed at ensuring an adequate level of data protection, as referred to in Chapter V of the GDPR. Information about the safeguards referred to in the preceding sentence can be obtained by contacting the Data Protection Officer.

Each of you or your representatives has the right to:

- access the content of your data,
- rectify, delete, or limit the processing of data,
- data portability,
- object.

Moreover, you have the right to lodge a complaint with the President of the Office for Personal Data Protection if you believe that the processing of personal data violates the provisions of the GDPR.
